## INFORMATION:

Montmartre Licensed Daycare will be offering full time and part-time care for children from ages 6 weeks to 12 years, with drop-in care available as scheduling permits. We are anticipating our doors being open for care by September 7, 2010. Our hours will be based on needs, with the maximum daily hours of operation expected to be from 6am to 6pm.

Applications for childcare will be accepted (spaces will be saved) on a first-come, first-serve basis, with priority being given to those registering for full-time care. *A non-refundable \$20 application fee, per child, must accompany this form to save your space and ensure care for your child(ren).* Remember, space is limited. We are licensed for 25 children in total: 3 infants (up to 18 months), 5 toddlers (18 months to 30 months), 14 preschool (30 months to age 5), and 3 school-age (Grade 1 and older).

Even if you may only use the daycare on a drop-in or casual basis, you must still be registered in advance.

After pre-registering with this form, your space will be saved and our Director will contact you in August to arrange formal registration, facility tour and receipt of an enrollment package.
